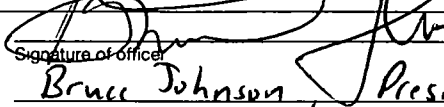

 Cornerstone is a statewide data management information system developed to facilitate the integration of community maternal and child health services provided to Illinois residents by the Illinois Department of Human Services, and to effectively measure health outcomes. Cornerstone is installed in over 3,382 workstations in over 320 tax exempt health care organizations across the State of Illinois, and is used to coordinate the delivery of integrated services to over 2.5 million distinct individuals. Cornerstone system users are estimated at 5,750.

4b (Code:) (Expenses \$ 2,496,878 including grants of \$) (Revenue \$ 2,504,767)
 Early Intervention/Centralized Billing Service Unit processes medical claims for services provided to patients enrolled in the Illinois Early Intervention program administered by the Illinois Department of Human Services. Approximately 910,000 claims were processed from July 1, 2010 through April 30, 2011 totaling \$81.8 million. This unit also generated and processed recoupment claims to Medicaid totaling nearly \$64 million. The Centralized Billing Services Unit processes claims for over 5,000 enrolled service providers serving over 20,000 active case loads at a single giving time

4c (Code:) (Expenses \$ 4,084,168 including grants of \$) (Revenue \$ 4,824,168)
 IPHCA provides maintenance and support services for an integrated Practice Management/Electronic Health Record/Electronic Dental Record system that ultimately will be utilized by 17 Federally Qualified Health Centers with delivery sites in medically underserved areas.

The goal of the network is to allow participating health centers to continue the services they provide to their community while realizing significant cost savings and benefits as a result of being part of a collaboration. The network will facilitate further integration and use of new technologies to enhance communication, trust, and renewed working relationships between diverse health center partners.

The network helps foster a working environment among health center partners, allowing for the free exchange of ideas and information between entities hundreds of miles away. It will create additional commonality among partners and will eliminate old excuses for not working together on common ground issues.
