Rallies & Crusades - Larry & Gloria travel across the country visiting churches and communities to spread the gospel of Jesus Christ. As an interdenominational ministry working with local pastors and laymen, the Lundstroms speak to families, couples, and individuals. They present an invitation for salvation coupled with teaching and encouragement to those who have already made a personal commitment. Their ministry covers city-wide crusades, evangelistic services or rallies, and speaking engagements of marriage and the family.

Ministry Outreach - The ministry provides a monthly newsletter to those who have attended a ministry event in the past year and to all supporters. Each issue has an article from Larry's perspective speaking on issues touching the church and current issues and events. There are also photos and information on the meetings they've held, and a schedule of upcoming events.
