**Note 1 Summary of Significant Accounting Policies**

**Date of Management's Review**

Management has evaluated subsequent events through September 30, 2011, the date on which the financial statements were available to be issued.

**Nature of Activities**

Chicago R.E.A.C.H. Foundation (the "Foundation") is an Illinois Not-for-Profit Corporation formed on September 27, 1994, located in Chicago, Illinois. The Foundation's mission is to arrange the provisions for medical and other care giving services to the frail elderly who live in Chicago who, without the provision of such services, would be eligible for admission to skilled care nursing facilities.

**Contributions**

Contributions, which are recognized when the donor makes a promise to give to the Foundation, are recorded as unrestricted, temporarily restricted or permanently restricted support, depending on the existence or nature of any donor restrictions. All contributions and grants are considered to be available for unrestricted use unless specifically restricted by the donor. Donor restricted contributions whose restrictions are met in the same reporting period are reported as unrestricted support.

**Property and Equipment**

Property and equipment are capitalized at cost or, if donated, at their estimated fair value. Donated amounts are reported as unrestricted support unless the donor has restricted the asset for a specific purpose. It is the Foundation's policy to capitalize expenditures for all items expected to have an estimated useful life of over one year and in excess of \$500.

Property and equipment are being depreciated using the straight-line method over the following estimated useful lives:

**Cash and Cash Equivalents**

For purposes of the statements of cash flows, the Foundation considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

**Accounts Receivable**

Accounts receivable are stated at the amount management expects to collect from state and federal governmental agencies for services provided by the Foundation to enrollees.

**Financial Statement Presentation**

The Foundation has adopted Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-for-Profit Organizations*. Under SFAS No. 117, the Foundation is required to report information regarding its financial position and activities according to three classes of net assets; unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. As permitted by the statement, the Foundation does not use fund accounting.

**Income Taxes**

The Foundation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. In addition, the Foundation qualifies for the charitable contribution deduction under Section 170(b)(1)(A)(vi) and has been classified as an organization that is not a private foundation within the meaning of Section 509(a).

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note 1      Summary of Significant Accounting Policies (Continued)**

**Functional Allocations of Expenses**

The costs of providing the various programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

**Cash Balances in Excess of Insured Limits**

The Foundation maintains its cash balances in one financial institution located in Chicago, Illinois and, at times during the year may maintain balances of cash and investments that exceed the federally insured limits of \$250,000. The Foundation's uninsured cash balances total approximately \$10,100,000 and \$7,200,000 at June 30, 2011 and 2010, respectively.

**Note 2      Fair Values**

The carrying amounts of cash and cash equivalents, receivables, prepaid expenses, payables and accrued expenses are reasonable estimates of their fair value due to the relatively short period to maturity of the items.

**Note 3      Property and Equipment**

**Note 4      Revenue Recognition**

Revenue and the related receivable from the State of Illinois is recognized each month a participant is in the R.E.A.C.H. program. Revenue rates from third-party payors are based on a reimbursement methodology determined by the rules and regulations of the applicable third-party payor. The third-party payor rules and regulations are complex and noncompliance may result in delay or adjustment of revenue.

The majority of the Foundation's revenue is based on the rules of the following third-party payors:

Illinois Department of Healthcare and Family Services (HFS) – A monthly rate, \$1,550.12 for all eligible participants 55 years and older, is established prospectively in a reimbursement contract with the State of Illinois Department of Public Aid. The HFS reimbursement account for approximately 95% of total revenues.

HCFA-Medicare-The Foundation's reimbursement under the Medicare program is based upon services rendered. Medicare reimbursement accounted for approximately 2% of total revenues.

Estimates are made to provide for uncollectable amounts billed and for adjustments made by the above third-party payor; however, those estimates are subject to variations.

**Note 5      Lease**

The Foundation leases two operating facilities from unrelated parties, The first lease will expire on December 31, 2011. The second lease had expired on May 31, 2011 and is currently being continued on a month to month basis. Under the terms of the second lease, the Foundation is responsible for their share of common area costs and real estate taxes, which are included as rent expense.

**Note 5 Lease (Continued)**

Rent expense for the years ended June 30, 2011 and 2010 are \$187,053 and \$185,047 respectively.

**Note 6 Transactions with Sacred Heart Hospital**

The Foundation and Sacred Heart Hospital share certain common management. No detailed records are maintained on the amount of time Sacred Heart personnel spend on the Foundation activities.

Certain salaries, related taxes and supplies are allocated between the two entities based on an estimate of time spent and usage. The amount of expense recognized by the Foundation for the years ended June 30, 2011 and 2010 are approximately \$128,000 and \$118,000, respectively.

**Note 7 Transportation Agreement**

The Foundation has an agreement with an unrelated entity to provide round trip transportation for participants. The Foundation is obligated to pay \$39,800 per month for services, through June 30, 2011. A new agreement has not been signed and is currently being continued on a month to month basis.

**Note 8      Temporarily Restricted Net Assets**

The Foundation receives grants from the Illinois Department of Transportation to purchase medium para transit vehicles. The Foundation received vehicle grants of \$57,746 and \$57,714 for the years ending June 30, 2011 and 2010, respectively. The purchased vehicles are restricted in its use to providing transportation for REACH participants and the Foundation is required to submit a semi-annual Certificate of Use to the Department of Transportation. The book value of these vehicles is \$92,372 and \$50,981 at June 30, 2011 and 2010, respectively. Depreciation expense was \$16,355 and \$6,733 for the years ended June 30, 2011 and 2010, respectively.

**Note 9      Profit Sharing Plan**

The Foundation sponsors a profit sharing plan for all eligible employees as defined. The contributions were \$30,000 and \$30,000 for the years ended June 30, 2011 and 2010 respectively. In addition, the Foundation has a 403(b) plan for all eligible employees as defined.

**Note 10     Going Concern / Subsequent Event**

Nearly all of the revenue for the Foundation is derived from payments remitted by the Illinois Department of Healthcare and Family Services (HFS). Commencing early in 2011, HFS has limited payments to existing enrollees and has not allowed the Foundation to enroll new individuals. The Foundation and HFS currently have a six month contract for services, which expires December 31, 2011. HFS has indicated to the management that the current contract may not be renewed. Management is in negotiation with HFS and cannot make a determination on whether the current contract will be renewed. If the current contract is not renewed and HFS ceases participation in the R.E.A.C.H. program; the Foundation's ability to continue as a going concern would be uncertain.

**Note 11     Reclassifications**

Certain amounts previously reported have been reclassified to conform to the current year's presentation.
