Artistic - Produce, Promote and Perform Ballets During The Joffrey Ballet's 2010-2011 Stars Season, the company presented four programs: mixed repertory program All Stars (October 2010, ten performances), Robert Joffrey's The Nutcracker (December 2010, 18 performances), Ronald Hynd's The Merry Widow (February 2011, 10 performances), and the mixed repertory program Rising Stars (May 2011, 10 performances). The total attendance for these programs was 74,965. Additional performances in Chicago included the Chicago Dancing Festival (August 2010, 2 performances), and the Spring Gala performance (April 2011, one performance). Total attendance for these events was approximately 15,000. The Joffrey Ballet's student matinee series offered The Nutcracker to Chicago Public School students for a discounted ticket rate of \$10. Approximately 2,000 students attended The Nutcracker (December 2010, one performance). The Joffrey Ballet toured to 13 cities, presenting The Nutcracker and Cinderella, as well as mixed repertory programs. Over 54,000 people attended 27 performances in cities including Cleveland, Washington D C, St Louis, Detroit, San Diego, Beaver Creek, Overland Park, Bloomington and Indianapolis among others.

Academy and Community Engagement Programs The Academy of Dance ("The Academy"), Official School of The Joffrey Ballet, is committed to providing a world-class education built on a foundation of classical ballet to students of all ages, levels and backgrounds who have a desire to dance. With the talents cultivated at The Academy, students can pursue careers as professional dancers at companies throughout the world, higher education opportunities in dance, or success in other fields. Through The Academy's programs, students develop a diverse set of skills including artistry, creativity, discipline and confidence, among others. The Academy's high-quality, educational programming forms future audiences and support for The Joffrey and builds the organization's reputation worldwide. In fiscal 2011, 1,031 students participated in The Academy Programs (this number does not include the adult drop in classes) and 1,393 individuals benefitted from the Community Engagement Programs.
