UNCMC annually submits compensation and related cost data to various independent third party firms which compile statistical information gathered from colleges, universities, and university related investment management companies. Using this data, the consulting firms produce a customized study for UNCMC showing compensation ranges, on a position by position basis, for comparable institutions. The summarized results of this study have been presented to the Company's Board of Directors. The Company also uses data from additional third party sources to determine comparable compensation for administrative positions. Compensation levels for each of the officers of the company (President and CEO and Vice Presidents) are approved annually by the Company's Board of Directors. Further, a compensation committee has been formed comprising of the Chairman, UNCMC Board of Directors and of the Chairman, UNC Investment Fund, LLC. The compensation committee reviews recommendations for officers and makes recommendations to the full Board.
