Meals Home Sweet Home Ministries operates a full service dining room at the Billy Shelper Center which prepares and serves three meals daily nearly 100000 meals this year 14 increase over the prior year to residents of the Center as well as tho se who walk-in from the street All meals are well-balanced meet USDA guidelines and are prepared by trained and licensed staff Volunteers are frequently used to help serve meals A large portion of food served comes from individual and restauran t donations In addition to residential and non-residential meals Home Sweet Home Ministries provides emergency food boxes to non-residents and sack lunches for residents who work during meal times
