


GRANTS ARE ALSO MADE TO FULFILL DONOR RESTRICTIONS ON GIFTS MADE FOR CAPITAL IMPROVEMENTS AND OTHER PROJECTS. DURING THE FISCAL YEAR, THE FOUNDATION PROVIDED \$872,697 FOR OPERATIONAL SUPPORT, \$29,265 OF ENDOWMENT INCOME, AND \$310,846 FOR DONOR RESTRICTED GIFTS INCLUDING THE CONSTRUCTION OF A NEW COTTAGE AND OTHER CAPITAL PROJECTS.
