Each year, following a specific formula, the Pine Rest Foundation awards grants to the Pine Rest Christian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$454,353 was made to provide funds for financial assistance for patients with the inability to pay for services. An additional \$417,870 was made available for education, prevention and support programs throughout the Hospital. A Job Support and Career Exploration Program was funded for emotionally disturbed adolescents in the residential program. Funding was provided for additional therapeutic resources available to implement scientifically proven higher outcome based treatment for children ages 12 and under. Funding was also provided for the initial hiring, training and support of research personnel that will be necessary to expand the number of self-sustaining clinical research projects at Pine Rest. A number of research, development and training programs were also funded.

Annual Golf Classic Fund Raiser. The net proceeds from the Annual Golf Classic is put into a Foundation Endowment that builds each year. Then every 3-years, a three-year rolling average is taken to provide support to the Patient Assistance Fund, a program which provides financial assistance for patients with the inability to pay for services, or invested in order to provide additional support to Pine Rest.
