Payout of any performance bonus is subject to overall organizational financial performance to ensure sufficient funds and are not paid until the financial results of the parent Organization are completed at the end of the fiscal year. If the Board approved budgeted net performance results of the parent Organization were not met, the bonus amounts would be reduced or eliminated so as not to create negative net earnings as compared to the budget for the Organization. Bonus pools for the CEO, Executive Management Team and other employees are approved by the Governance and Compensation Committee, the Finance Committee, Executive Committee and ultimately the Organization's Board of Directors. The Governance and Compensation Committee approves all bonus amounts paid to the CEO, Executive Staff reporting to the CEO and estimated bonus for Executive staff not reporting to the CEO.
