In April 2011, Sandra Gibson, Arts Presenter's President and CEO announced she would not seek to renew her contract. Therefore, the focus of the board's Executive Committee turned to planning for the CEO's departure, establishing criteria for the hire of a new President and CEO, and filling the office with an interim CEO. The typical review process involves the President and CEO's self assessment in response to a set of priorities and annual operating plan established by the board of directors along with the annual unaudited financial statement. The Executive Committee reviews the CEO's performance on the accomplishments and challenges of the previous year. As a part of the review process, the President and CEO also provides documentation on salary/compensation of comparable performance arts service organizations to determine any change in CEO compensation. The recommendation to continue the CEO written employment contract is based on the Executive Committee's assessment of the CEO and approval by the board. The President and CEO tracks and monitors the progress through monthly conference calls with the Executive Committee, and weekly conference calls with the chair of the board. In June 2011, APAP President & CEO Sandra Gibson, ended her service to the association. To promote a smooth and seamless transition, Gibson was retained at Arts Presenters as a special consultant from July 1, 2011-October 31, 2011. The executive's role transitioned to one of supporting the organization on an as-needed basis at the direction of an Interim CEO while the APAP Board of Directors implemented a transition plan to move the association to its next phase. As a part of the plan, the board established the "APAP Future Working Group," a steering committee that worked closely with the full board, staff and members to guide the association's pathway of change and advancement. A search committee was also formed to select Gibson's successor and was led by board Vice Chair, Josh LaBelle. In April 2011, the APAP board of directors unanimously agreed to appoint Jim Copenhaver, current board member, as interim CEO. Jim Copenhaver requested a leave of absence and recused himself from all votes and board deliberations at that time. Copenhaver partnered with Gibson in the CEO role starting in April 2011 until her departure as President & CEO, and assumed full responsibility as the Interim Chief Executive Officer on July 1, 2011. Copenhaver remained in that role until Mario Garcia Durham was selected to fill the President and CEO position in October 2011.</p>
