



These difficulties have principally resulted in a transaction where a transfer is intended to be made between two assets accounts, but inadvertently affects either an income or an expense income. An adjusting entry of \$2,601 at year end was required to correct these mistake and to bring the ending funds balances into balance with the cash accounts held in various banks.
