 Workforce Investment Act (WIA) funds are utilized to provide outreach and case management services to assist, train and place dislocated workers into employment. These services are provided within the existing Job Centers established in the State of Wisconsin.

**4b** (Code: ) (Expenses \$ 70,267 including grants of \$ ) (Revenue \$ 88,173 )  
 Four training sessions were conducted to provide instruction in four modules of Manufacturing Skills Standards Certification (MSSC). The modules included Safety, Quality Practices and Continuous Improvement, Manufacturing Processes and Production and Maintenance Awareness. The average post test score was 94.545. All twelve participants successfully completed the courses. The program achieved a 75% entered employment rate. The range of wages per hour were \$10.42 to \$15.02. The sessions were held in southern Wisconsin.

 The organization provided outreach and recruitment for Trade Adjustment Assistance Act information sessions, assisted at the sessions the International Aerospace Machinists and Workers conducted, and served as reference and resource connections to the local workforce system as needed. The organization worked on fourteen sessions in which 66 persons participated.
