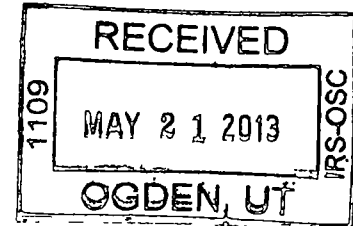

Starting with our Year end 6/30/13 returns we will be using KerberRose SC to prepare our returns and make certain that all returns are timely filed. We have also made arrangements to have the necessary information available to us by August from our brokerage firms. Our problem in the past has been the fact that our year ends June 30, but we were trying to tie out all investments and needed the 12/31 brokerage statements.

In addition to our arrangements with the brokerage firm, and KerberRose, SC, we will be having a meeting in August of each year to review all financial information to ensure that all information is available for a timely filing.

The Rhinelanders Woman's Club was established in 1898 as part of an effort to help provide needed services in the Rhinelanders Area. Our mission is to provide volunteers throughout the community. Our volunteers are not reimbursed for their volunteer work in any way. Total volunteer hours by our members are consistently more than 7000 hours per year to such organizations as the Food Pantry, Cancer, Hospice, Alzheimer's, Domestic Abuse, reading programs for children, just to name a few. We have a working knowledge of all of the not-for-profit groups we contribute to. We were fortunate to have been bequeathed a large amount of money and have used this money to offset budget cuts and provide funding for additional resources. Recently we gave \$10,000 to the
