CURRENTLY 3 LOCAL UNIONS HAVE OFFICE SPACE IN THE FACILITY AND 6 HOLD REGULAR MEETINGS IN THE BUILDING. THERE IS ONE LOCAL UNION THAT USES THE FACILITY FOR BI-ANNUAL TRAINING SESSIONS. THE FACILITY IS ALSO AVAILABLE TO BE RENTED BY THE GENERAL PUBLIC AND HAS BEEN UTILIZED FOR CONFERENCES, RECEPTIONS, GRADUATIONS, AND BRIDAL SHOWERS. APPROXIMATELY 10-15 OF THESE EVENTS WERE HELD AT THE FACILITY DURING THE FISCAL YEAR. THE FACILITY IS ALSO AVAILABLE TO ALL 501c3 ORGANIZATIONS.
