In fiscal year 2011, Plains Art Museum served 45,428 visitors of all ages through high quality art exhibitions, educational programs, live music, and outreach activities. The museum organizes six to eight major exhibitions annually with an equal number of smaller exhibitions. The museum's permanent collection of 3,800 objects is also used for special exhibitions and research, occasionally shown in national and international venues. Exhibitions focus on artists in the community and region. In fiscal year 2011, the museum presented the following exhibitions: *The White Album The Beatles Meet the Plains Art Museum* Individual to Icon Portraits of the Famous and Almost Famous from Folk Art to Facebook*The Frederick B.
