One-on-one relationships with caring adults helped students to stay in school. Initiatives included: The "Compass" Project a mentoring program connecting students with caring adults at school, FirstSchool Gardens, a partnership with Blue Cross Blue Shield and other area organizations designed to create gardens in 5 schools in Moore County to increase physical activity and healthy eating opportunities for students, and service-learning opportunities in the area's middle and high schools.
