ST JOSEPH'S COMMUNITY FOUNDATION (SJCF) WAS ESTABLISHED IN 2003 BY CHRISTUS HEALTH TO PERPETUATE THE LEGACY OF THE SISTERS OF CHARITY OF THE INCARNATE WORD, WHO HAVE SERVED THE COMMUNITY SINCE 1911 AND WORKED TIRELESSLY TO DEVELOP AND SUPPORT A NUMBER OF LOCAL COMMUNITY HEALTH INITIATIVES IN PARIS, TEXAS AND SURROUNDING COMMUNITIES. FOUNDATION DIRECTORS RAISE FUNDS FOR VARIOUS SERVICES, PROGRAMS AND FACILITIES TO IMPROVE THE HEALTH OF THE COMMUNITY. IN ADDITION, THE FOUNDATION PROVIDES FUNDING FOR SELECT PROGRAMS IN THE RED RIVER VALLEY THROUGH GRANTS, WITH AN OVERALL GOAL TO SUPPORT THE CREATION OF A HEALTHIER COMMUNITY. SJCF SUPPORTS AND COLLABORATES WITH AGENCIES THAT ARE WORKING TO ADDRESS THE ROOT CAUSES OF AT-RISK LIFESTYLE BEHAVIORS AMONG AT-RISK POPULATIONS WITH A GOAL TO IMPROVE THE HEALTH AND WELL BEING OF THE RED RIVER VALLEY COMMUNITIES. IN AWARDING GRANTS, SJCF WILL FOCUS ON PROGRAMS THAT SERVE THE ECONOMICALLY POOR AND UNDER-SERVED, WOMEN AND CHILDREN AND THE ELDERLY, AND THOSE MISSION AND VALUES ARE COMPATIBLE WITH THOSE OF THE FOUNDATION. A DRIVING PRINCIPLE OF THE FOUNDATION IS THAT COLLABORATION AMONG COMMUNITY ORGANIZATIONS IS ESSENTIAL TO MAXIMIZE FINANCIAL AND HUMAN RESOURCES. THERE ARE SIMPLY NOT ENOUGH RESOURCES TO DO IT ALONE OR TO DUPLICATE SERVICES. IN ADDITION, THE SISTERS HAVE ALWAYS HAD A PREFERENTIAL OPTION FOR SERVING THE POOR, AND THE FOUNDATION WILL CONTINUE TO BE GUIDED BY THAT GOAL. FUNDING PROGRAMS AND SERVICES THAT ARE IN KEEPING WITH THE LONG HISTORY AND TRADITION OF THIS COMMITMENT. CHRISTUS HEALTH WAS FORMED IN 1999 TO STRENGTHEN THE 146-YEAR-OLD, FAITH-BASED HEALTH CARE MINISTRIES OF THE CONGREGATIONS OF THE SISTERS OF CHARITY OF THE INCARNATE WORD OF HOUSTON AND SAN ANTONIO. FOUNDED ON THE MISSION "TO EXTEND THE HEALING MINISTRY OF JESUS CHRIST," CHRISTUS IS CHALLENGED TO REACH OUT TO, AND BEYOND, THE MORE THAN 60 COMMUNITIES WE SERVE TO HELP THOSE IN NEED.
