



The purpose of this amendment was to comply with the U.S. Department of Housing and Urban Development ("HUD") requirements in connection with the refinancing of an existing HUD Loan encumbering certain real estate owned by the Corporation and commonly known as AHEPA Phase I Apartments.

The undersigned, being the duly elected, constituted and acting Secretary of AHEPA 53, Inc., a Missouri non-profit corporation (the "Corporation"), does hereby certify that the Board of Directors, at a duly held meeting of the Board of Directors or by unanimous consent, duly approved amending the Articles of Incorporation of a General Not For Profit Corporation of the Corporation adopted on March 24, 1980, to include the following language in the Articles of Incorporation as of April __, 2011:

"Notwithstanding anything to the contrary contained in the Articles of Incorporation, and while HUD is the insurer or holder of the mortgage:

The Project shall be the sole asset and business purpose of the corporation.

The mortgagor entity is authorized to execute a note, mortgage, and security agreement in order to secure a loan to be insured by the Secretary and to execute the Regulatory Agreement and other documents required by the Secretary in connection with the HUD-insured loan.

If any of the provisions of the organizational documents conflict with the terms of the note, mortgage, security agreement or HUD Regulatory Agreement ("HUD Loan Documents"), the provisions of the HUD Loan Documents will control.

No provision required by HUD to be inserted into the organizational documents may be amended without prior HUD approval, so long as HUD is the insurer or holder of the note.

No provision in the organizational documents that results in any of the following will have any force or effect without the prior written consent of HUD:

- (i) Any amendment that modifies the term of the mortgagor entity;
- (ii) Any amendment that activates the requirement that a HUD previous participation certification be obtained from any additional member;
- (iii) Any amendment that in any way affects the note, mortgage and security agreement on the Project or the Regulatory Agreement between HUD and the mortgagor entity;
- (iv) Any amendment that would authorize any member other than the Board of Directors to bind the mortgagor entity for all matters concerning the Project which require HUD's consent or approval;
- (v) A change in the corporate structure of the mortgagor entity; or
- (vi) Any change in a guarantor of any obligation to the Secretary.

Any incoming officer, director or member of the non-profit corporation agrees to be bound by the note, mortgage, security agreement, the Regulatory Agreement and any other documents required in connection with the HUD-insured loan to the same extent and on the same terms as the other officers, directors or members.

Notwithstanding any other provisions, upon any dissolution, no title or right to possession and control of the Project, and no right to collect the rents from the Project, shall pass to any person who is not bound by the Regulatory Agreement in a manner satisfactory to the Secretary.

The officers, directors and members of the corporation and any assignee of the corporation and their officers, directors and members are liable in their individual capacity to HUD for:


- (i) Funds or property of the Project coming into its possession, which by the provisions of the Regulatory Agreement, the person or entity is not entitled to retain;
- (ii) Its own acts and deeds, or acts and deeds of others which it has authorized, in violation of the provisions of the Regulatory Agreement;
- (iii) The acts and deeds of affiliates, as defined in the Regulatory Agreement, which the person or entity has authorized in violation of the provisions of the Regulatory Agreement; and
- (iv) As otherwise provided by law.

The corporation shall not voluntarily be dissolved or converted to another form of entity without the prior written approval of HUD.

The corporation has designated Leon Spanos, President of the Corporation, as its official representative for all matters concerning the Project which require HUD consent or approval. The signature of this person will bind the corporation in all such matters. When a person other than the person identified above has full or partial authority of management of the Project, the corporation will promptly provide HUD with the name of that person and the nature of that person's management authority."

The purpose of this amendment was to comply with the U.S. Department of Housing and Urban Development ("HUD") requirements in connection with the refinancing of an existing HUD Loan encumbering certain real estate owned by the Corporation and commonly known as AHEPA Phase I Apartments.
