The club provided assistance to numerous local charities which included the Boy Scouts of America, Ladies of Charity (a local helping hand group), Teen Challenge of St. Louis (Alcohol and Substance Abuse rehab center for young men) and numerous other causes which benefit our area. The club purchased two defibululators for the High Ridge Fire Protection district. The largest single donation was to Rotary International to the Paul Harris fund.
