For charitable, scientific & educational purposes primarily promoting public/private partnership, advancing research and technology development, including entrepreneurship The following were NDSU Research & Technology Park's unique programs in 2011 Entrepreneurship Academy program, in partnership with the Fargo Public Schools, West Fargo Public Schools, Moorhead Public Schools and the South East Education Cooperative, hosted its 2nd annual youth entrepreneurship academy for 11th and 12th graders Aspiring entrepreneurs learned to identify a possible business, develop a product or service, create a marketing plan and pitch the idea to potential investors The Virtual Incubator continued to help companies shorten time to market for new technologies by providing entrepreneurs with valuable resources and services through a virtual community During the application process, entrepreneurs complete a targeted assessment tool that is used to develop a coaching plan As entrepreneurs move through the program, they are provided with the tools they need to successful start and grow their business The Entrepreneurship Program turns visionary ideas into high-tech businesses and nurtures new technologies to help translate them into commercial enterprises At the Technology Incubator, the Organization worked hard to create an entrepreneurial culture that fosters innovation and encourages ingenuity In June of 2008, the Organization invested in NDSU Research Park Ventures, LLC The partnership was incorporated for the purpose of operating a renaissance fund corporation for the City of Fargo The purpose of the fund is to raise funds to be used to make investments in zone and research park projects and to assist in financing of renaissance zone projects in a manner that will encourage capital and real estate investment in the City of Fargo which, in return, will encourage the expansion of technology based entrepreneurial business development The project zones are located in downtown Fargo and in the NDSU Research & Technology Park at North Dakota State University
