

The Foundation believes this is an invalid rejection. There is no reasonable cause for the rejection.

Upon receiving the denial notice the Foundation's Director of Finance called the IRS 1-800 number listed on the notice. Also on the conference call was Corrie Scott of our CPA firm that prepared the Form 1128 and Form 990. They spoke to Mr. Patterson ID#1000195074 and Mr. Hudson ID#1000221043. They explained the Foundation had not changed year ends in the past ten years. They said the Foundation filed the Form 1128 (because an extension was filed) on a timely basis (filed on November 15, 2011). They mailed the Form 1128 to the IRS Service Center in Ogden, Utah, which is the address listed in the Form 1128 instructions. Mr. Patterson and Mr. Hudson said the Form 1128 for a nonprofit should have been sent to the IRS Service Center in Cincinnati, Ohio; however the Form 1128 instructions does not specify a different filing address for nonprofit organizations. .

They were instructed by Mr. Patterson and Mr. Hudson to file the Form 990 for the short year period and include in the return an attachment stating that the Foundation followed the process to change to a June 30 year end. Please send an affirmation letter confirming the change in year end.
