The Foundation has had funds invested with the South Dakota Community Foundation for several years. As a result of an audit of the South Dakota Community Foundation, they were informed that they needed to change the way they were reporting funds invested in agency funds with their foundation. As a result, the South Dakota Parks and Wildlife Foundation had to add these funds to its financial statements as a Beneficial Interest in Assets Held by the South Dakota Community Foundation. Since these funds have been invested with the South Dakota Community Foundation for many years, an adjustment was made to Beginning Net Assets during the current fiscal year to adjust for these assets.
