Briefly describe the organization’s mission

The mission of the University of South Dakota Foundation ("Foundation") is to provide private resources for The University of South Dakota ("USD"), in order to increase the excellence of the USD student's educational experience, with the overriding goal of creating the best small public university in the country emphasizing excellence in teaching. The Foundation will supplement the State's funding to USD primarily in the following areas: 1) providing scholarship funds to increase the academic excellence of the student body and the quality of their educational experience, 2) providing funds to construct new campus facilities and restore, repair and maintain existing facilities, 3) providing funds for salary augmentation and other support of the academic faculty and for the support of USD museums and other various auxiliary programs, facilities and services.

Provide scholarship funds to increase the academic excellence of the student body and the quality of their educational experience. During the fiscal year ended June 30, 2011, the University of South Dakota Foundation ("Foundation") provided \$9,792,406 to the University of South Dakota ("USD"). Included in this amount was scholarship support in the amount of \$5.5 million. Scholarships are awarded for both recruiting and retention purposes. A new freshman recruiting scholarship program was started in 2003 that has been instrumental in helping to accomplish USD's enrollment objectives. The amount of scholarships provided since this new program began has increased from \$1.9 million to \$5.5 million (292% increase). Total enrollment increased 28% since 2003 and the number of freshman fitting the ACT requirements to receive the scholarship increased 17%. The retention rate also continues to increase as a result of the freshman scholarship program.

Provide funds to construct new campus facilities and restore, repair and maintain existing facilities. The Foundation has been instrumental in a major renovation and reconstruction of facilities at USD. During the fiscal year ended June 30, 2011, \$2.2 million was provided to USD for this purpose. Since 1996, \$49 million has been provided for facilities that have enhanced the students educational experience and opportunities and have resulted in a new Health Science Information Center building, the renovation of a Childcare facility, replacement of the Dakota Dome roof, renovation of a technological state of the art Allen H. Neuhauser Center for Communications and Journalism, renovation of two historical buildings - Old Main and Belbas Center - to be used for classrooms and student services, renovation of Slagle Auditorium to be used for major events and programs, renovation of the Lee Medical School building, construction of the Muenster University Center - student center, and construction of a new Beacom School of Business building.

Provide funds for salary augmentation and other support of the academic faculty, and funds to support USD museums and various other auxiliary programs. During the fiscal year ended June 30, 2011, the Foundation provided \$2 million to USD to support operations and programs. Included in this total was \$774 thousand provided for faculty, in the form of salary augmentation, faculty travel and professional development and research. Support to students for travel, assistantships, internships, research, etc was provided in the amount of \$346 thousand. Lectures, programs and operational support benefited by \$925 thousand.
