Hastings College has in place a number of academic partnerships to increase opportunities for students, open doors for underserved students, and assist the community. Creighton University in Omaha collaborates with Hastings College on a nursing partnership whereby students earn a Bachelor of Arts degree from Hastings College and then enroll in the one-year Creighton university accelerated nursing program to earn a Bachelor of Science degree in nursing. Hastings College also offers a 3-2 engineering program that leads to degrees in mechanical, electrical, civil, chemical, and aeronautical engineering. Students spend the first three years at Hastings taking pre-engineering and liberal arts courses and the last two years at a partner engineering school such as Washington University - St. Louis, Columbia University, university of Nebraska, and the University of Colorado. Additionally, Hastings college partners with central community college (CCC), a public, two-year college with campuses in Hastings, grand island, and Columbus, Nebraska, to offer college bound, a transfer initiative for students who have earned associate's degrees, and college bound education, an articulation program for teacher education candidates. International partnerships include student exchange agreements between Hastings College and universities in Germany, England, Spain, Ireland, Italy, Russia, Thailand, and the Netherlands.
