The Good News Broadcasting Association, Inc. is a user-driven provider of life change, generated by researching, developing and distributing Bible engagement tools that help people take a daily, positive step forward in their lifelong spiritual journey. Bible teaching and engagement methodologies include traditional terrestrial broadcasting through radio, podcasts, cellular technology, SMS text messaging, print, Internet and person-to-person sharing through the latest social media technology. The non-profit purposes of The Good News Broadcasting Association span the United States, with media outlets in every state and an international reach through 11 locations across the world. Through all of the variety of the ministry’s delivery channels, the single focus of the organization is to walk with people daily into a living, growing and passionate relationship with Jesus Christ.

	Radio ProgramBack to the Bible is a 25-minute radio program where listeners become part of a personal Bible study, with Dr. Woodrow Kroll as their teacher. Each weekday, Dr. Kroll helps listeners get a solid grasp of biblical principles and apply them to real life. The program was aired on an average of 780 terrestrial radio outlets across the U.S. during the fiscal year. A 28-minute television version was also provided online. Bible MinuteThe Bible Minute provides biblical insight for everyday life. Each Bible Minute topic has an accompanying Bible Study, giving participants an opportunity to engage God’s Word in a meaningful, practical way. Primary distribution of the Bible Minute is radio, with e-mail and RSS formats also available online. Literature and Media ProductsThe Good News Broadcasting Association, Inc. creates CDs, printed studies, and other Bible teaching and engagement items that are available for sale and, in some cases, at no direct cost to individuals around the world. Hundreds of thousands of items designed to help people win the day spiritually are distributed across the U.S. and in other countries annually. InternetWebsites owned and operated by Good News Broadcasting provide additional resources and materials for those involved in the various ministries. More than 1.7 million visited these sites during the past fiscal year.

	International MinistriesBack to the Bible International communicates the Word of God in ways that are clear, culturally appropriate and readily understood. Through 11 global locations, listeners in 85 countries have the opportunity to receive Bible teaching, discipleship and Gospel outreach in a language that is meaningful to them.

	Next Generation OutreachgoTandemgoTandem is a daily spiritual growth experience that utilizes multi-channel communication to provide the truth of the Bible to thousands of people, multiple times a day. Integrating pre-recorded voice messages, text messaging and e-mail, goTandem helps people grow spiritually by helping them engage the Bible regularly, no matter where they are. This multi-channel, multi-touch methodology is all based on powerful research that has demonstrated that investing time in the Bible four or more times a week makes a significant difference in the lives of individuals. Proving its effectiveness, a recent study showed that 75% of goTandem users stated that goTandem effectively increased their desire to engage the Bible. goTandem services are currently available in their entirety in the U.S. and Canada, and in email format around the world with users in 55 additional countries. FootnoteIn order to reach those not currently interested in consuming traditional Christian media with the truth of the Bible, Good News Broadcasting set out to create a 30-minute television program designed to act as a bridge to goTandem. The resulting program, Footnote, featured real stories highlighting the ways in which spirituality plays a significant role in all of the most common human experiences and desires. Episodes produced aired monthly as paid programming on WGN America, a nationally-syndicated network based out of Chicago, IL from November 2010 through September 2011 and reached 660,000 Nielsen Households during that period.
