As the nonprofit fundraising arm of MCC, the Foundation serves over 43,000 students annually by addressing their financial and educational needs through scholarships, educational enhancement programs, and the improvement of learning facilities Many programs take place on the five MCC campuses around the metropolitan area including the annual Storytelling Celebration hosted by MCC-Maple Woods The event draws 20,000 people to over 100 venues across the area celebrating the rich diversity of culture and history through the telling of stories The Foundation administers scholarships and endowments, sponsors alumni and donor recognition events, and leads the annual fundraising campaign This year the Foundation assisted the College in raising over \$269,000 for capital projects to improve and add to facilities across all campuses A highlight during the fiscal year was the Foundation's support for the Health Science Institute (HSI) near the MCC-Penn Valley campus HSI was created by renovating an outdated empty building into a state-of-the-art training facility for three nursing and 16 allied health programs serving 1,000 healthcare career students from MCC and other colleges and hospitals Other projects include the Emergency Book Fund which provided \$12,151 in assistance to students in purchasing needed text books and lab supplies, providing awards for art shows held in the Carter Art Center, and supporting activities and programs held on the various campuses and in the community throughout the year

Scholarships are the signature program of the MCC Foundation providing financial support for tuition and academic coaching for students with financial need Over 50% of MCC students require assistance in order to realize their dreams of achieving a higher education Many students receiving Foundation scholarships are the first in their families to attend college and the scholarships have changed the lives of recipients and their families The Foundation provided \$247,514 in scholarships funds to 334 students
