We nurture the intellectual, creative, and emotional lives of children in a diverse learning community in which an integrated, experiential curriculum prepares them for a lifetime of learning, leadership, and service. 50 students were enrolled for the 10/11 school year and 17 students were enrolled in the extended day program.
