THROUGH OUR ENERGY ASSISTANCE PROGRAM, THE FUEL FUND OF MARYLAND MADE A TOTAL OF \$900,728 AVAILABLE TO THE 14 AGENCIES THAT COMPRISE OUR SERVICES NETWORK \$864,250 OF THAT AMOUNT WAS USED FOR ACTUAL BILL PAYMENTS \$126,478 WAS USED BY THE AGENCIES FOR PROGRAM EXPENSES. IN ADDITION, FFMD RECORDED 2,082 5 HOURS OF VOLUNTEER SERVICE WHICH HAD A VALUE OF MORE THAN \$40,000 THESE 14 AGENCIES SERVED IN BALTIMORE CITY AND THE COUNTIES OF ANNE ARUNDEL, BALTIMORE, CARROLL, HARFORD, HOWARD, MONTGOMERY AND PRINCE GEORGE'S TOGETHER THEY ASSISTED 7,425 HOUSEHOLDS OR ALMOST 21,000 INDIVIDUALS FIFTY-FOUR PERCENT OF THEM WERE CHILDREN

	THROUGH OUR ENERGY CONSERVATION EDUCATION PROGRAM KNOWN AS WATT WATCHERS OF MARYLAND, WE ENROLLED 323 PEOPLE, OF WHOM 263 GRADUATED. THIS MEANS 80% OF OUR PARTICIPANTS COMPLETED THE CLASS AND LEARNED THE BEHAVIOR-CHANGE TECHNIQUES WE TEACH RELATED TO FAMILY'S ENERGY CONSUMPTION. THE 24 TOTAL SESSIONS WERE HELD IN 20 DIFFERENT LOCATIONS THROUGHOUT OUR SERVICE TERRITORY AND IN WASHINGTON COUNTY WW GRADUATES ALSO RECEIVED AN ENERGY CONSERVATION KIT WITH A RETAIL VALUE OF OVER \$50 THAT CONTAINED 12 DIFFERENT ITEMS THE FAMILY COULD USE TO FURTHER ENHANCE THEIR ENERGY CONSERVATION SAVINGS. SOME OF THESE WERE A LOW FLOW SHOWER HEAD, SHOWER TIMER, WEATHER STRIPPING, DRAFT STOPPERS AND A CFL LIGHT BULB. GRADUATES WHO EMBRACED THE EASIEST-TO-IMPLEMENT PRINCIPLES THEY LEARNED IN THE CLASS FOUND THEY COULD SAVE 10-20% ON THEIR UTILITY BILLS WITH ONLY MINOR CHANGES TO THEIR ROUTINES, SUCH AS LOWERING THEIR THERMOSTAT IN THE WINTER TO 68 DEGREES AND NOT RAISING IT ABOVE 78 DEGREES IN THE SUMMER AND SETTING THEIR WATER HEATER NO HIGHER THAN 120 DEGREES. THOSE WHO TOOK ADVANTAGE OF ALL OF THE TIPS THEY STUDIED, PLUS THE RESOURCES THEY LEARNED ABOUT SUCH AS WEATHERIZATION AND UTILITY COMPANY DEMAND REDUCTION PROGRAMS, COULD ENJOY SAVINGS AS HIGH AS 50% WHEN COMPARING PREVIOUS YEAR MONTHS TO THE SAME MONTHS AFTER GRADUATION. EACH FULL CLASS INCLUDES 3 HOURS OF INSTRUCTION ON ENERGY CONSERVATION AND AN HOUR ON FINANCIAL LITERACY. WE INCLUDE THE LATTER IN ORDER TO INFORM PEOPLE OF WAYS IN WHICH THEY CAN PUT THEIR ENERGY SAVINGS TO GOOD USE.
