Program Service Accomplishments

The mission of the Omohundro Institute of Early American History & Culture is to further the study, research, and publication bearing upon American history approximately to the year 1815. The Institute strives to stimulate interest in the early period of American history, encourage and assist writers and scholars in their studies and research, maintain the accepted standards of historical accuracy and integrity, and to preserve and advance understanding of the enduring contributions of the founders of the Republic.

Research Related to America's Colonial Period

Since 1943, the Institute has been active in documentary research and editing, publishing collections of manuscripts deserving circulation in print and new editions of classic works no longer available, as well as annotated editions of the papers of a number of prominent early Americans. The Institute published three books this year: John L. Brooke, *Columbia Rising: Civil Life on the Upper Hudson from the Revolution to the Age of Jackson*; Wendy Bellion, *Citizen Spectator: Art, Illusion, and Visual Perception in Early National America*; and Paul W. Mapp, *The Elusive West and the Contest for Empire, 1713-1763*. Many books are in production and copyediting, plus the Institute continues to review numerous manuscripts and proposals.

The Institute offers one-year and two-year postdoctoral fellowships, awarded each year to the most promising candidate in an international competition. Institute fellows devote their time to research and writing. During this fiscal year, three fellowships were awarded.

The Institute's editorial apprenticeship program, which graduates on the average three to four people per year, is an integral part of the Master's and Ph.D. program in history at the College of William and Mary. The program trains the chosen in the procedures of scholarly editing and publishing. Former apprentices have gone on to become editors at major publishing houses.

The Kellock Library is a non-lending library located at the Institute. The library consists of 7,000 books and 3,000 microfiche either purchased, donated, or published by the Institute. The library exists for the purpose of research by the Institute staff, the College of William and Mary history department, and visiting individuals doing research.

The William and Mary Quarterly

Volume 68 of the Quarterly contains four Forums, eight stand-alone articles, two Sources and Interpretations pieces, one Research Note, two book Forums, and eighteen book reviews or book essay reviews. The volume, totaling 760 pages, is 39 pages shorter than the previous one.

The number of Forums is noteworthy-perhaps unprecedented. In April seven scholars comment of "Mapping Ethnogenesis in the Early Modern Atlantic" by James Sidbury and Jorge Canizares-Esquerro, an essay first presented at the WMQ-EMSI Huntington Workshop for emerging work in the field. July's Forum, "Transformations of Virginia: Tobacco, Slavery, and Empire," introduced by James Horn, features two essays initially presented at the Institute conference "The Early Chesapeake: Reflections and Projections," St. Mary's City, Maryland (Nov. 19-21, 2009); John C.

Coombs, "The Phases of Conversion: A New Chronology for the Rise of Slavery in Early Virginia," and Douglas Bradburn, "The Visible Fist: The Chesapeake Tobacco Trade in War and the Purpose of Empire, 1690-1715." Six scholars comment, and Coombs and Bradburn respond. The October issue offers two Forums related to the American Revolution. The first highlights Eric Nelson's "Patriot Royalism: The Stuart Monarchy in American Political Thought, 1769-75," with responses by three scholars and the author's reply. The second, "Economics and American Independence," presents a historiographical review and think piece by Staughton Lynd and David Waldstreicher, with four respondents and the author's rejoinder. The October issue also contains two Critical Forums in the Reviews of Books section, one focusing on Kathleen N. Brown's *Foul Bodies: Cleanliness in Early America*, and the second on Christopher Tomlin's *Freedom Bound: Law, Labor and Civic Identity in Colonizing English America, 1580-1865*. The first has two rounds of commentary by three scholars and the author; the second presents five comments and the author's response. All of the Forums provide readers with multiple perspectives on important new scholarship.

The early Chesapeake is certainly well represented in volume 68. In addition to the Forum on Virginia mentioned above, articles examine Spain's role in the founding of Jamestown (July) and reexamine the stories about cannibalism and the Starving Time at Jamestown (January). Besides the two Forums on the Revolution, the October issue offers Rhys Isaac's last publication, "Lighting the Fuse of Revolution in Virginia, May 1765: Rereading the 'Journal of a French Traveller in the Colonies.'" Other articles provide fresh takes on seemingly familiar topics. Katherine A. Grandjean reinterprets the Pequot War in New England by putting it in the context of environmental history and assessing the effects of food shortages (January). Catherine O'Donnell revises the story of the origins of the American Catholic Church in the same issue. Francois Furstenberg employs the methods of book history to

illuminate George Washington's place in a late eighteenth-century abolitionist
network (April).

What counts as-or is directly relevant to-"early America" continues to be a matter
of debate in the field. Two articles move outside of what once been considered the
geographic boundaries of the field: Juliana Barr's "Geographies of Power: Mapping
Indian Borders in the 'Borderlands' of the Early Southwest" (January) and Randy N.
Browne's "The 'Bad Business' of Obeah: Power, Authority, and the Politics of Slave
Culture in the British Caribbean" (July). The Ethnogenesis Forum visits all the
continents rimming the Atlantic. In this era of ever-broadening geographic
frameworks (Atlantic, continental, hemispheric, and global histories), however,
Karen Halttunen's "Grounded Histories: Land and Landscape in Early America," her
October convener's essay reflecting on the previous year's WMO-EMSI Huntington
Workshop, makes an eloquent call for deeply textured local histories.

With only two Sources and Interpretations essays, volume 68 may seem to
underrepresent this format when compared to the volumes of the past few years. But
the two essays are significant. James O'Neil Spady's "Power and Confession: On the
Credibility of the Earliest Reports of the Denmark Vesey Slave Conspiracy" (April)
examines crucial archival documents overlooked in Michael P. Johns

bring together leading scholars to comment critically on commissioned
historiographical essays and bibliographies. The Institute colloquium met
frequently during the 2010-2011 academic year, for informal discussions of scholarly
work in progress.

The Institute offered six conferences during 2010-2011. In September, "Household,
Commonwealth, and Political Economy," the annual meeting of the British Council in
Early American History, was hosted at the University of Oxford. "The Age of Sail,
1450-1850," was sponsored by University of British Columbia and the Institute in
October at the University of British Columbia. In February, "Centering Families in
Atlantic Worlds, 1500-1800," was sponsored by the University of Texas at Austin's
Institute for Historical Studies and the Institute. "Warring for America,
1803-1818," was held in the Madison Building of the Library of Congress in March
under the sponsorship of the Institute, the Huntington Library, the John W. Kluge
Center at the Library of Congress and New York University's Department of History.
In May, the WMQ/EMSI/Huntington Workshop, presented "Women in Early America" at the
Huntington Library. In June, the Seventeenth Annual Institute Conference was held
at SUNY New Paltz.

St. George Tucker Law Papers

St. George Tucker: Law Reports and Selected Papers, 1782-1822, is an annotated
edition of the legal manuscripts of the Virginia jurist and legal commentator best
known for his 1803 edition of Blackstone's Commentaries. From the 1780's to the
1820's, Tucker served at every level of the Virginia court system and spent the last
dozen years of his career as a federal judge, sitting with Chief Justice Marshall on
the U.S. Circuit Court.

The body of the edition consists of Tucker's reports of some 1200 cases. These fill thirty-five manuscript notebooks covering cases in the Virginia courts, 1786-1811, which Tucker later had bound together in three volumes. Tucker also compiled three notebooks of federal cases, 1813-1822. The edition is divided into "chapters," corresponding to Tucker's numbered notebooks. The opening "chapter" is a general introduction consisting of a biographical sketch of Tucker and an extensive consideration of his career as a lawyer and judge. From matter includes, among various editorial apparatus, a description of the manuscript and its provenance and a short-title bibliography. There are three appendices: a biographical register of the bench and bar, a glossary of selected legal terms, and documents relating to the rupture between Tucker and his Court of Appeals colleague, Spencer Roane. Back matter includes tables of statutes, cases cited, and cases reported by Tucker.

Originally expected to consist of two volumes, the edition will fill three substantial volumes. As of the end of the year, the manuscript was being reviewed by the Institute's outside readers. The next step, assuming positive readers' reports, will be obtaining approval of the UNC Press Board. If all goes smoothly, publication will likely occur in the fall of 2012.
