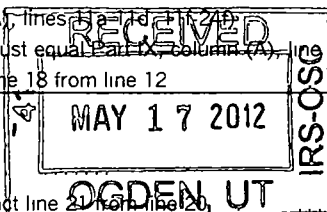

Entrepreneur Program - CIT recognizes that the availability of early-stage capital is a critical need of many emerging technology companies by making connection with "hard to access" private and federal funding sources. CIT Growth Acceleration Program (GAP) Funds make seed-stage equity investments in Virginia-based technology and life science companies with a high potential for achieving rapid growth and generating significant economic return. CIT's Commonwealth Energy Fund makes seed stage equity investments in Virginia-based energy ventures that have achieved a "commercially available", revenue-ready stage of development capable of sustaining a high-growth business model while generating jobs in Virginia. CIT's federal funding Assistance Program identifies and accelerates opportunities for Virginia's small technology businesses to obtain SBIR, STTR and ATP awards and other government contracts.

4b (Code _____) (Expenses \$ 1,437,348. including grants of \$ 0.) (Revenue \$ 1,084,826.)

Research and Development Program - CIT brings together public and private sector teams to develop and deploy solutions that not only address regional and national challenges, but also produce innovative and marketable solutions. CIT is working with Virginia's ten regional technology councils to establish the Commonwealth Innovation Index, a tool to assist the public and private sector decision makers in their regional and statewide planning and investment decisions. In a recent initiative, CIT has been called upon to develop a comprehensive R&D strategic roadmap for the Commonwealth to identify areas worthy of institutional focus and economic development. In addition, CIT also develops and executes federally-funded research programs targeting the areas of defense and national security, renewable energy and marine sciences.

Broadband program - The mission of CIT's Broadband program is to "accelerate the socio-economic growth of Virginia's rural and underserved areas through the application and use of broadband telecommunications." CIT supports the Office of Telework Promotion and Broadband Assistance, which resides within the office of the Secretary of Technology. In addition, CIT is Virginia's designated entity for The American Recovery and Reinvestment Act broadband mapping and planning activities under a federal grant to expand broadband access and adoption in communities across the U.S.
