THE AEROSPACE EDUCATION PROGRAM HAD CAREER EXPOS, FIELD TRIPS, SUMMER CAMPS, AND OTHER EVENTS TO TRIGGER INTEREST IN THE INDUSTRY. WE WORKED WITH PILOTS IN TRAINING EXERCISES AND AIRPORT ENVIRONMENTS AS WELL AS SPONSORED E-MISSIONS WITH CHILDREN AND TEACHERS. 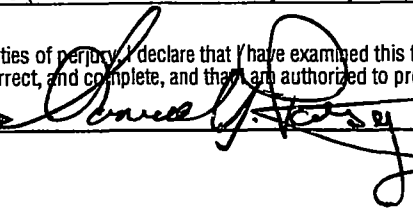
