EDUCATION Primary services were school constructions, renovations and electrification for rural communities in San Ramon, which totaled \$7,371. Also, \$5,642 was spent for the construction of numerous rural school kitchens. Finally, \$1,719 was spent to support librarian salaries at the local public library.

HEALTH Funds totaling \$4,34 was spent on salaries and maintenance of he Los Pipitos Center for Children with Disabilities located in San Ramon. Also, \$2,200 supported a senior citizens support and fellowship group in San Ramon, while \$1,475 was spent on providing nutritious meal service to the maternal health center and \$440 supported fumigation supplies for the malaria prevention program.

SCHOOL PARTNERSHIPS These programs provided 13 rural schools with classroom supplies for the entire school year. These schools serve 40 to 90 students at the primary level, grades 1 to 6.
