THIS OUT-OF-SCHOOL PROGRAM DEVELOPS A STRONG FOUNDATION OF ACADEMIC SKILLS IN ELEMENTARY AND MIDDLE SCHOOL STUDENTS TO ENSURE READINESS FOR SUCCESS IN A COLLEGE-PREPATORY HIGH SCHOOL CURRICULUM. IN 2010-2011 TEACHERS, WITH THE SUPPORT OF VOLUNTEERS, IMPLEMENTED INDIVIDUALIZED CURRICULUM FOR 70 STUDENTS. THESE STUDENTS ATTENDED 124 DAYS DURING THE SCHOOL YEAR FOR 2.5 HOURS EACH DAY, AS WELL AS, 22 DAYS DURING THE SUMMER FOR 4 HOURS EACH DAY.
