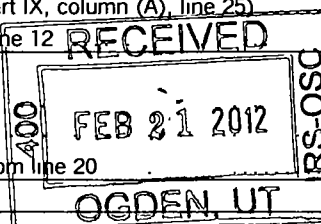

High impact grants of approximately \$100,000 each are extended each June  
to local, worthy nonprofits selected by our members. Impact Austin solicits  
proposals for programs or projects in five focus areas: culture, education,  
environment, family, and health and wellness. These grants are funded  
by combining annual donations from members. Our membership requirements  
currently are simply to be female and to donate \$1,000 each year. Beyond  
this, each member can be as engaged or involved as she chooses. One hundred  
percent of each member's \$1,000 donation goes to our grant recipients. In  
June of 2011, Impact Austin gave grants of \$108,400 to five nonprofits  
within the local community.

Girls Giving Grants teaches young women the art and importance of giving.  
Combining individual donations of \$100, young women in grades 8 through 12  
as of October 1 learn the power of collective giving and best practices

grantees. In April of 2011, Girls Giving Grants extended a \$5,200 grant  
to one nonprofit within the local community.
