The school offers merit-based admissions, cultivates strong family partnerships, and ensures its economic diversity by meeting all demonstrated need for tuition support.

Harlem Academy is an accredited independent school that introduces high-potential children from low-income communities to an advanced academic environment. Our goal is to go beyond simply overcoming the disparities facing low-income children; we seek to launch students' academic careers by providing opportunities for personal growth, unleashing their creativity, and challenging students at every turn.

Founded in 2004, Harlem Academy has added a grade every year and now serves 104 students in first through seventh grade. At the foundation of Harlem Academy's model is a dedication to rigorous academics, character development, and family partnership.

The school is open from 7:30 a.m. to 6 p.m., providing ample time for a challenging program, an advisory period, after-school tutoring and enrichment, and athletics.

During their first year at the school, the average Harlem Academy student sees a 16 percentile-point increase on nationally standardized tests. Harlem Academy students then continue to achieve high scores through the later elementary and middle school years, when disadvantaged students typically see a drop in performance. Ninety-six percent of students score above the national average on the ERB CTP4, with students sharing these top scores across all income levels.

Harlem Academy completed a rigorous accreditation process in May 2011, earning

In June, the New York Times honored the school with the gold prize at their 2011 Nonprofit Excellence Awards for its innovative, effective, and replicable practices in nonprofit management. The team has shared Harlem Academy's model with 16 prospective and established schools from nine states and two foreign countries, as well as in a number of public forums.
