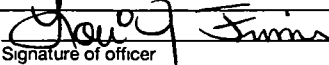

Economic and Housing Environment: In FY 2011 Grow South Dakota made 8 loans totaling \$887,500, creating or retaining 86 jobs through the Revolving Loan Fund. The organization provides technical assistance to all applicants. The organization made 4 housing loans totaling \$4,000 through the downpayment assistance program.

4b (Code:) (Expenses \$ **37,486** including grants of \$) (Revenue \$ **38,557**)

Grow South Dakota assisted one non-profit organization by making available 9 vehicles to further that organization's work in low-income weatherization and housing rehabilitation.

4c (Code:) (Expenses \$ **0** including grants of \$) (Revenue \$ **0**)

During the Year, Grow South Dakota formed Rockyford Schools LLC which was rendered a qualified active low-income community business (QALICB) as defined in Section 45D of the Code of Treasury Regulations. As a QALICB, Rockyford Schools LLC was able to received Qualified Low-Income Community Investments (QLICI) loans from two Community Development Entities (CDE) under the New Market Tax Credit Program. These QLICI are being used in a \$22 million project to construct a new school in Porcupine, South Dakota, which falls within Shannon County, one of the highest distressed counties in the nation. Rockyford Schools LLC will ensure tax credits are not jeopardized during the duration of the compliance period. This program aligns with Grow South Dakota's Tax-Exempt Purpose by creating jobs in an economic distressed area, by fostering educational opportunities, and by promoting overall growth and sustainability for the community.
