- **Part II** – As we are on a cash basis, have no capital, no liabilities and no assets other than cash, we do not prepare a balance sheet. Although our fiscal year is from July 1 to June 30, we solicit dues for the following season starting in late April and the majority of our members pay in May or June. Therefore our cash position is highest at the end of our fiscal year.

Part III – Affiliated with the World Affairs Council of America, the purpose of the 800 member WACHH is to inform and educate its members and the wider community about foreign policy issues.

To accomplish these objectives, WACHH had two programs, Speakers and Outreach to the area community and schools.

- The Speakers Program meets twice a month from October until May and offers WACHH members and their guests an extensive program on foreign affairs, economic and national security issues through presentations by foreign affairs practitioners, academicians, government, business and military leaders.
- In this fiscal year we had 14 such presentations. Attendance at these presentations averaged approximately 375 attendees. We were able to increase the capacity through a move to a new venue. The direct cost for these programs was \$16,055.

Outreach has two elements. The first is a High School effort in which volunteers from WAC conduct presentations and lead foreign affairs discussion groups at local high schools. WAC has minor direct costs associated with this effort. The second is a series of programs open to members and non-members. The summer sessions are based on the Great Decisions book purchased through the National Association. The Fall Forum
