THE COMPENSATION COMMITTEE SHALL BE COMPRISED OF THE ORGANIZATION'S STATE DIRECTOR, OR IN THE ABSENCE THEREOF OR IN THE EVENT THE STATE DIRECTOR HAS A CONFLICT OF INTEREST, THE EXECUTIVE DIRECTOR OF THE ORGANIZATION'S NATIONAL AFFILIATE, AND SUSAN RAKOV, WHO HAS ACCESS TO AND KNOWLEDGE OF THE COMPENSATION ARRANGEMENTS FOR DOZENS OF SIMILARLY SITUATED NONPROFIT ORGANIZATIONS AROUND THE COUNTRY. THE BOARD MAY VOTE, AT ANY TIME, TO APPOINT ADDITIONAL MEMBERS TO THE COMPENSATION COMMITTEE. THE COMPENSATION COMMITTEE WILL ESTABLISH ACCEPTABLE COMPENSATION PACKAGES AFTER REVIEWING AT LEAST ONE OF THE FOLLOWING: (I) INFORMATION ABOUT COMPENSATION PAID BY SIMILARLY SITUATED TAX-EXEMPT ORGANIZATIONS FOR SIMILAR SERVICES, (II) CURRENT COMPENSATION SURVEYS COMPILED BY INDEPENDENT FIRMS, OR (III) ACTUAL WRITTEN OFFERS FROM SIMILARLY SITUATED ORGANIZATIONS. THE COMPENSATION RANGE WILL BE ESTABLISHED IN ADVANCE OF PAYING COMPENSATION WHENEVER POSSIBLE, AND IN NO EVENT SHALL EXCEED \$100,000 PER YEAR FOR A FULL-TIME EMPLOYEE POSITION UNLESS THE FULL BOARD OF DIRECTORS VOTES TO APPROVE SUCH AMOUNT AS REASONABLE. THE COMPENSATION COMMITTEE WILL DOCUMENT IN WRITING THE INFORMATION ON WHICH IT RELIES IN DECIDING UPON THE TERMS OF COMPENSATION ARRANGEMENTS.</p>
