Instruction - Rabun Gap - Nacoochee School is a 100-plus year old independent boarding and day school providing co-education college-preparatory in grades six through twelve that has a covenant relationship with the Presbytenan Church Rabun Gap - Nacoochee School (RGNS) educated approximately 340 students from 13 countries and 15 states for the current fiscal year with an average class size of 11 The Middle School had an enrollment of approximately 80 boys and girls International students comprise approximately 20 percent of the student body The faculty averages 15 years of teaching experience, with an average of 8 years at RGNS Of the approximately 50 classroom teachers and 6 residential faculty, 50 percent hold graduate degrees or higher Advanced Placement (AP) courses offered in all academic departments with 94 students enrolled in an AP course and 68 percent of AP candidates received a score of 3 or higher, making them eligible to receive college credit for their work With 24 clubs and student organizations, students participate in a wide range of activities The international students have a diverse range of activities that include all types of generational contribution
