**DURING FY 2011 WE INCREASED THE SERVICES WE PROVIDE TO HOMELESS PARENTS, AND CONTINUED TO ACHIEVE TANGIBLE, MEASURABLE OUTCOMES FOR OUR FAMILIES. IN FY 2011 WE SERVED A TOTAL OF 174 CHILDREN FROM 110 FAMILIES (113 ADULTS.) OF THESE, 91% WERE AFRICAN-AMERICAN, 4% WERE CAUCASIAN, 4% WERE MIXED RACE, AND 1% WERE HISPANIC. 97% OF OUR FAMILIES WERE SINGLE-FEMALE HEADED, AND 3% CAME FROM TWO PARENTS FAMILIES.**
