WNCAP served 452 clients in Case Management, assisting with benefit applications, locating housing, utility and other financial assistance, and application to drug assistance programs. In addition WNCAP conducted bi-weekly HIV/AIDS Support groups.

In WNCAP's HIV Prevention programs, 55 African American women participated in the SISTA program, and 80 individuals participated in the Safety Counts program, both programs are curriculum based, CDC approved programs designed to focus on strategies to prevent the spread of HIV. In addition, close to 5,000 individuals were reached in various programs at Substance Abuse Centers, local schools and after school programs, Health Fairs, and opportunities to increase awareness of the dangers of HIV. WNCAP also distributed 185,000 condoms in our region.
