MUST Day Service Centers provide food, clothing, financial assistance, and employment services to persons in financial distress. These centers distributed over 547,000 pounds of food and 200,000 items of clothing to the community during the fiscal year ended June 30, 2011. In addition, 164 households received assistance with rent, utilities, and prescriptions. Collectively, over 335 clients were able to obtain employment, returning over \$4.7 million in wages back to the community.

MUST Housing programs work to address the emergency needs of persons experiencing homelessness, the transitional needs of those recovering from homelessness, and the long-term housing needs of those struggling with chronic homelessness as a result of a disability. These programs provided over 145,000 bednights of rest to persons recovering from homelessness. MUST’s emergency shelter serves over 1,000 persons annually, including nearly 200 children in families. Transitional housing assists approximately 40 clients per year, and MUST’s supportive housing programs offer stable housing for up to 70 persons who are chronically homeless.

The Homelessness Prevention and Rapid Re-Housing (HPRP) Program is a tenant-based model that seeks to assist families at imminent risk of losing their housing, or those who have recently become homeless. This model has worked to help over 660 persons during the year with temporary housing assistance during a very challenging economic time and is supported through a special grant from the American Reinvestment and Recovery Act.
