Our "mentoring menu of program services" includes community based mentoring, school based mentoring, workplace mentoring, Big Fitness (activities focused on reducing childhood obesity), Tripod, Science Program, Continuing Education, as well as group mentoring services for children on the waiting list. Through these various programs, we served a total of 5,800 children, families, parents and volunteers during the fiscal year 2010-2011. A total of 1,932 matches were served over 800 new matches were made during the year. Our waiting list continues to exceed 1,000 children

due to the increasing demands in the community and the effects of the economic recession in our community.
