DURING THE CURRENT YEAR'S CAMPAIGN, 976 FAMILIES WERE SERVED IN WASHINGTON COUNTY AND 812 FAMILIES WERE SERVED IN CARTER COUNTY. 324 HAMS WERE PROVIDED FOR UNICOI COUNTY, AND 300 HAMS FOR JOHNSON COUNTY.
