A similar program offers prescription assistance. The Providence Hospital Foundation is grateful to the many sponsors, contributors, volunteers, businesses, and organizations that make possible the annual Festival of Flowers. Through this celebration, the Foundation seeks to benefit not only Providence Hospital and its health care mission but the entire community by promoting an interest in gardening and beautification and encouraging the preservation of the natural beauty that is so much a part of Mobile's heritage. Net proceeds, approximately \$70,000, from the 2011 Festival of Flowers supported Cardiology Services. In the past years, monies raised through the Foundation's efforts have been used to improve technology in the Heart Center, provide \$250,000 for women's services and over \$148,000 to renovate the pediatric unit on the 8th floor. The foundation has assisted in the process of enhancing 3-dimensional imaging capabilities in radiology. A state-of-the-art infant security system was purchased in 2008. Proceeds from the 2009 Festival were used to purchase a high definition Video Bronchoscopy System. Bronchogenic lung cancer remains the most common cause of cancer death in the United States. The new system enhances the ability to diagnose lung disease. Our long term plan calls to assist the hospital with further initiatives in cardiac care, cancer services and women's health.
