enrichment programs. These contributions directly affected the lives of almost 25,000
residents of the community through programs offering indigent assistance, meals for
the elderly, emergency relief, after-school tutoring, CPR certification training,
shelter and counselling for victims of abuse, and assistance for teen mothers.
Distributions also benefitted local residents with disabilities, youths involved in
scouting and 4H, and renal dialysis patients requiring assistance with transportation
or medication.
