Alpha-1 Research Network The Alpha-1 Research infrastructure provides support for a network of Alpha-1 investigators worldwide. It is one of the Foundation's most valuable assets and includes the DNA & Tissue Bank, Genetics Laboratory, and more than 70 affiliate Clinical Resource Centers (CRCs). The Foundation also organizes scientific meetings, conferences, workshops, and symposia which further the understanding of findings in the field and promotes research, clinical endpoint measurements and other potential breakthroughs. The Alpha-1 Grants and Awards Program is the heart of the Foundation's research activities. Its scientifically rigorous peer-reviewed process provides the framework to evaluate and recommend meritorious research projects for funding within the scope of the Alpha-1 research agenda

PFT Study The Alpha-1 Foundation completed its first multi-center clinical study entitled "Targeted Detection of Alpha-1 Antitrypsin Deficiency in Patients referred for Pulmonary Function Testing". Eighteen different medical institutions nationwide have enrolled more than 3,000 individuals in the study. The study's objectives were 1) Determine the detection rate of severe and heterozygous Alpha-1 Antitrypsin Deficiency in symptomatic COPD patients referred for pulmonary function testing, 2) Determine which pulmonary function parameters associated with COPD patients are more likely to test positive for Alpha-1, and 3) Identify the age distribution of positive testing for Alpha-1 and evaluate which pulmonary functions are associated with age and an Alpha-1 diagnosis. The study was completed Spring 2010. Publication of findings is expected Spring 2012.

Florida Detection Program This program has led to testing over 18,000 individuals for Alpha-1 since inception. In fiscal year 2011 over 1,800 individuals were tested. The goals of the program are to provide free testing to individuals in the State of Florida and to promote Alpha-1 education for healthcare professionals. In 2011, speakers were provided for 4 medical grand rounds, 4 lectures providing CME credits, 8 lectures providing CEU credits, and 6 medical related conferences. Activities to educate the public and at risk individuals are conducted and the partnerships developed with other organizations in the state has led to increased interest from the physicians
