During the year ending June 30th 2011, the Wurtman Ner-David Foundation, Inc. was engaged in the following programs:

1) RIKMA Fellowship Program:

The Foundation continues to operate the RIKMA fellowship program designed to address the leadership needs of Jewish communities in Israel and the United States. The RIKMA fellowship program includes an intensive study program, visits to active communities and organization as well as hands-on experience for the fellows, who are required to design and implement projects in their communities.

There are currently seventeen fellows participating in the program, none of them currently receiving stipends. Two of the fellows are currently residing in the US engaged in positions of communal leadership. Fellows living in Israel meet on a regular monthly basis for half day seminars as well as at least one two-day retreat during summer months. Fellows in the US meet once a year with fellows visiting from Israel participating in an educational trip. All fellows continue to be in regular contact with mentors and the director of the program.

The Foundation has formed strategic partnerships with communal organizations both in the US and Israel in order to enrich the training program and provide project opportunities for fellows.

Examples of projects Foundation fellows have been involved with over the last year are:

- managing a prominent community center in central Jerusalem
- Organization of programs for children from low socioeconomic backgrounds-for example, including summer camp for both Jewish and Arab children.
- Eight independent congregations headed by our fellows in various parts of Israel.
- a creative community of artists and local residents in an underprivileged neighborhood of Jerusalem.
- A Reform congregation was founded in Rosh Ha'ayin.
- Israel's first chaplaincy has been established by a fellow in a Jerusalem hospital.
- Prominent rabbinic positions in Boston and Kansas City.

2) Russian Immigrants Program:

The Foundation continues to develop and implement a program to assist Russian "aliya" activists who fought for the right to emigrate to Israel from the Former Soviet Union.
