The mission of Summer on the Hill (SOH), a year-round, supplemental academic program, is to enrich the education of promising, low-income public school students from the Bronx, Washington Heights, and Harlem, prepare them for selective schools and colleges, and offer guidance to their parents. SOH is a unique NYC program that enrolls promising students at the elementary level and works with them through high school -- for ten years. Each year, SOH challenges 250 students with accelerated academic classes, school and college test prep classes, and instruction in the arts and sports. We offer 5th, 8th, and 12th graders individual guidance on school and college choices. Although housed on the campus of the Horace Mann School with access to the School's facilities, SOH is an independent 501[c]3 program that raises its own funds to operate a high-quality program. Since its establishment in 1994, SOH has served 1,000 public school students and their families. SOH has placed 95% of its 2004-20

	<p>Since its establishment in 1994, Summer on the Hill (SOH) has provided important educational opportunities to 1,000 promising, low-income public school students from the Bronx, Washington Heights, and Harlem. The average annual income of SOH families is \$45,000. Only 40% of SOH parents hold a college degree. Despite many challenges to achievement, SOH students are motivated to work hard and accomplish their goals. The following list indicates the range of achievement at SOH - Attendance and Attrition. Students in lower grades demonstrated their enthusiasm for SOH by attending the academic year Saturday program -- a sixth day of school - at the impressive attendance rate of 90%. SOH's attrition rate is approximately 5% yearly - Middle School Placement. SOH has placed over 100 elementary level students who have been judged ready for the transition to an independent school. Without SOH's guidance, it is unlikely that families would have known about and applied to the schools listed here. All SOH students attending independent schools receive enough financial aid to make their enrollment possible. Since 2004, SOH has placed 50 boys at the George Jackson Academy, 50 students at the De La Salle Academy, and 20 students at the Horace Mann's Middle School. Students have also been placed at Calhoun, Nightingale Bamford, and Riverdale Country - High School Placement. SOH 8th graders are regularly accepted to selective high schools. In 2010 and 2011, 20 SOH students were accepted to the most competitive NYC public high schools: Bronx Science, HS for American Studies at Lehman College, HS for Math, Science, and Engineering at City College, and LaGuardia HS. Students have also been accepted to boarding schools (St Paul's, Phillips Exeter), Catholic schools (Mt. St. Ursula, Fordham Prep), and independent schools (Horace Mann, Riverdale) - College Placement. 95% (215) of SOH's 2004-2011 high school graduates have matriculated in over 125 colleges and universities, including Columbia, Cornell, Dartmouth, Georgetown, Harvard, the University of Pennsylvania, Yale, and MIT. In 2011, a high school senior was accepted to all 12 colleges and universities to which she applied, and is now at Harvard - SOH college graduates are working in education, finance, health, insurance, and technology, or are enrolled in graduate or medical schools. Two college graduates who teach at NYC public schools also teach in SOH's Grade 3-8 Program - Awards. In March 2009, Dr. McIvor, SOH's founder and Executive Director, received the Lewis Hine Distinguished Service Award for his work in expanding educational opportunities for low-income youth - Recognition from Foundations. Since 1994, SOH has received over \$7 million in grants and individual gifts in support of our program. Recent grants have come from these foundations: Altman, Aspen Community Fund, Assurant Group, Austin, Charina, Colgate-Palmolive, Davis, Donchian, Educational Foundation of America, Charles Hayden, JPMorgan Chase, Lear Foundations, MetLife, Niles, Oaklawn, Pforzheimer, Time Warner, US Airways, and the Yankee Stadium Community Benefits Fund. The New York City Council, NYC Department of Education, and the NYS Department of Health have provided support to SOH.</p>
