 Puerto Rico Public Housing Administration (Project Learn Program):
 Project Learn is a comprehensive program that impacted 7,112 participants between the ages 6 through 21, creating a fun and secure environment for the youth to develop their full potential as productive individuals giving them trainings to increase their knowledge of the alcohol, tobacco, and other drugs use, abuse, and consequences. Programs supported included Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance, and Sports and Recreation. All participants were exposed to educational forums, prevention programs against the use and abuse of alcohol, tobacco and other drugs, family support systems, community development programs and sports and recreation programs. For fiscal year 2010-2011, 100% of the work plan presented to PRPHA was accomplished. Program results are as follows: 69% of participants increase their general average of their academic grades; 91% of participants were promoted or graduated during the fiscal year; and 72% improved their conduct in the classroom. More than 2,000 residents from the different housing projects received more than 80 hours of educational activities or orientations including topics related to responsible paternity, technology and the development of skills to prevent risky behaviors in their children, healthful lifestyles and development of micro-enterprises.

 21st Century Community Learning Centers: (Power Hour, Tutoring assistance, Triple Play, Sports and Recreation)
 21CCLC is a program which main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2010-2011, 507 participants benefited from the program. Participant's ages fluctuates from 6 to 12 years old. At least 437 participants attended to tutoring service for 30 days or more. Program results statistics were as follows:
 • All participants improve their knowledge related to alcohol, tobacco, and other drugs use and abuse and its consequences
 • All participants improve their knowledge related to sexuality and the consequences of sexual relations at an early age
 • 39% of participants improve their grades in Spanish courses
 • 100% of participants advance grade or graduate
 • 43% of participants improve their overall conduct and discipline in the classroom
 • 2,364 people in communities served benefitted of more than 20 hours of educational and prevention activities

 OJP Mentorship and Leadership Programs:
 Implemented BGCA core programming: Character and Leadership Development; Educational and Career Development; Health and Life Skills. Programs supported included Passport to Manhood, Keystone, Smart Girls, Smart Moves, Fan Club and Smart Leaders. All participants improve their knowledge related to prevention, drugs use and abuse and early age conduct consequences. Supporting activities included excursions and seminars among others. Some participants were given the opportunity to participate in the mentorship activities as mentors to younger participants.

Through the SPF-SIG program a necessity study was conducted related to alcohol prevention activities in the communities served; and a Community Forum was held to discuss the issue where 40 people participate.
